- 1. Meeting was called to order at 6:01 P.M. by Vice President Ed Schlosser.

- 3. Secretary Marlene Rymer resigned. Wiitala stated that she would be willing to take the secretary position.

- 5. Motion to approve the order of agenda was made by Rymer, second by Koehler. Motion carried by voice vote 4-0

- 11. Rymer stated that she had spoken with Marla from WVLS and that she was told that it is not illegal to have more than 1 person from same family on board. Director Smith commented that Marla had also stated to her that it is not good practice.
- Director Smith reported that she would be doing a required continuing education class "Basic Collection" on line. She also requested to attend WVLS "Basic Cataloging" in Wausau on Thursday February 13. Motion to allow Director Smith to attend was made by Rymer, second by Koehler. Motion carried. Voice vote 4-0
- 13. Short discussion of 2014 budget was held. We will have a 'hard copy' of the budget at the February meeting for further discussion if needed.

- 15. Discussion of the WVLS Trustee Essential Training:Chapter 3 Bylaw-Organizing the Board for Effective Action. Director Smith stated that Westboro By-laws need to be updated and that the Policy portion needs to be separate from the by-laws.
