- 1). Meeting called to order at 6:00 PM by President Nancy Wiitala.
- 2). Roll Call Trustees present Nancy Wiitala, Shanna Berger, Lori Hanson, Lori Dums, Ed Schlosser. Library Director Candice Smith was present.
- 3). Motion to approve order of Agenda made by Berger, 2<sup>nd</sup> by Schlosser. Motion carried.
- 4). Motion to approve June 10 meeting minutes was made by Dums, 2<sup>nd</sup> by Berger. Motion carried.
- 5). Motion to accept Treasurer's report as given was made by Berger, 2<sup>nd</sup> by Wiitala. Motion carried.
- 6). Motion to pay bills as submitted was made by Schlosser, 2<sup>nd</sup> by Dums. Motion carried.
- 7). Director's Report: Circulation for June was 744 (up from May and down from June '13 at 872). Director Smith reported she attended the WVLS Technology Workshop. She reported that she won a "Raspberry PI" for the Westboro Library. A device that is comparable to a desktop PC and can be used for a variety of different things while taking up less space than a PC. Director Smith reported that Indianhead will no longer participate in the WIN program. Northern Waters and WVLS will continue to participate and a meeting in August will be held to take vote on continuing participation. Director Smith also reported receiving a \$1,000 Grant from United Way for 2015. She also noted Mad Scientist entertainment by the Woller Family is scheduled for July 30<sup>th</sup> at the Westboro Library.
